The college is offering B.Sc. degree course only.

The college is running only UG programmes in Science subjects. The college is implementing the curriculum as prescribed by North Maharashtra University as per the norms. The Curriculum is designed by the parent university and is implemented by the college through a rational well planned curricular delivery method such as adherence of academic calendar and time table, equitable distribution of workload as per the time table, maintenance of teaching plan etc.,

The entire curriculum delivery is planned on annual basis and further annual plane is divided in to monthly weekly plane for complication of the course.

It is observed by the committee that, the college has not yet obtained 2f and 12 B status from the UGC but college has continues affiliation by the University and smallest college of the University. The institution also provides remedial classes to educationally backsword students. Question banks are prepared by the college teacher are used for the betterment of students in their better academic performance. For the successful implementation of the curriculum, college organises seminar, workshops for the academic enrichment of the students and faculty members.

Minor Research Project (MRP,s) were funded by the VCRMS. There are six faculty members with PhD including Principal and two faculties have registered for Ph.D. Principal is recognized as research guide for North Maharashtra University. Four stuff members are NET qualified and three staff members are SET qualified. The college faculty has published twenty six research papers in good reputed journals and also one stuff member has publish 9 books.

Extension activates are conducted through NSS in collaboration with Government Departments & NGOs & cooperate enterprises. Blood Donation, Plantation, Health Check up, Adoption of village, environment sustainability. Industrial visit field work surveys etc are the prominent extension activities conducted regularly. The students of the college are actively involved in blood donation camp, eye camp, organ donation and thereby helping to save the lives of the needy. The college has conducted National Seminars & workshops.
